


AND WHEREAS all parties have agreed to the following timetable leading to the hearing of the Plaintiffs' Motion for Certification;

IT IS HEREBY ORDERED:

1. **THAT** the preliminary motion of the Defendant Eckler Ltd. will be heard on July 27, 2018, regarding whether the Plaintiffs' claim as against Eckler can proceed in light of determinations made in former proceedings brought under the *Companies' Creditors Arrangement Act*, R.S.C., 1985, c.
